### ASSAM: KILLING FIELD OF INDIAN ARMY

1. Name - Gambhir Gogoi  
Father's Name - Tikeswar Gogoi  
Vill. & P.O. Bhadoi Pach Ali.  
Dist. ~~Lakhimpur~~ Dibrugarh  
Date of Occurrence - 1.12.90  
Place of occurrence - Sabitri Tea Estate

**DESCRIPTION:** On 1 December, 90 in the evening, an army platoon arrested Gambhir Gogoi from his residence, Sabitri Tea Estate; and on 6th December army delivered the dead body of Gambhir Gogi to his family.

2. Name - Poulas Urang, 55 Years (Laksmi)  
Village Ouguri, P.O. Lakhi Pothar, Lakhimpur  
P.S. Digboi  
Date of occurrence - 1.12.90  
Place of occurrence - Orang

**DESCRIPTION:** Poulas Urang was a fisherman. On 1 December 1990 early in the morning Poulas Urang went to his work and there he faced the army. He was afraid and tried to escape. The army shot him and he died in the spot.

3. Name - Bipin Gogoi  
Vill. - 2 No. Borpothar Gaon,  
P.O. & P.S. Bhadoi Pach Ali, Lakhimpur,  
Date of Occurrence - 4.12.90.  
Place of occurrence - Bhadoi Pach Ali, at Charipung Forest.

**DESCRIPTION:** On 4.12.90 Bipin Gogoi went out from residence with scooter at 4 p.m. and the army delivered the dead body of Bipin Gogoi on 6 Dec.'90 to his family. Eye witness says that he was picked up by army.

4. Name - Puhari Das, 60 years  
Vill. Barjan Bangaon  
Date of occurrence - 27.11.90  
Place of occurrence - Digboi

**DESCRIPTION:** Puhari Das was killed by army on 27th in 1990 at Barjan Bangaon of Digboi and on the same day 2 young girls were missing and another young girl's dead body was found in the paddy field.

5. Name - Parama Payaing, 60 years  
Vill.- Dodhiagaon,  
Date of occurrence - 5.12.90

Place of occurrence - Chabua

**DESCRIPTION:** Parama payaing, mother of two kids and then pregnant was killed by the Indian Army at Dodhiagaon near Chabua. She was the wife of Budhram Payaing. At the time of killing she was milling rice.

6. Name - Charat Sonowal,  
Vill.- Kalijan, Tinsukia  
Date of occurrence - 16.12.90  
Place of occurrence - Lakhpathar.

**DESCRIPTION:** Charat Sonowal, a teacher of Kalijan near Lakhpathar was tortured brutally to death by army. CPI leader Promod Gogoi, claimed Sonowal's death as inhuman.

7. Name - Jatin Gohain, 18 years  
Father's Name - Girish Gohain  
Vill. - Dhemaji  
Date of occurrence - 21.12.90  
Place of occurrence - Lakhimpur

**DESCRIPTION:** Jatin Cohain was picked-up by the army from a Shaktiman Truck No. 2882. He was on his way to business work, when he was picked. Jatin's dead body was brought to the Dhemaji Hospital. The doctor declared him dead and the post mortem report said that his death was due to severe head injury. His father Girish Gohain registered a case (967/90) at Dhemaji Police Station.

8. Tarash Sonowal - 16.12.91.  
An Army major arrived at the house of Tarash Sonowal, aged 30, of village Bardalani Kacharigaon in Dhemaji district at daytime on December 16, 1991. He was in a civil dress and so Tarash's mother could not recognise him. He introduced himself falsely as Tarash's friend and the mother took him to the paddy-field to meet Tarash who was working there. He at once took the revolver out of his pocket and fired at his right leg. Then he fastened Tarash with a rope and forced him to utter "I am an ULFA member" and took him to the army camp at dusk. There Tarash was brutally tortured to death. Later on, the armymen carried the deadbody to a nearer wood and fired at it in discriminately at night. They then announced that Tarash was killed in an encounter.

9. Manik Saikia & Manik Daflary - 28.3.96.  
Manik Saikia, (aged 30 years) and his friend Manik Daflary, (aged 27 years) of villages Batgharia and Amolguri respectively in Dhemaji district went to Naroathan Chariali on a motor-cycle on March 28, 1996. There they met Jogleswar Saikia, on SSB officer of Dhemaji Bangalmari SSB Camp. The three quarelled for some reason or other. The two friends on their motor-cycle returned to their home

accompanied by the SSB CO on another motor-cycle. On the way, at a solitary place near Uriamguri bridge they again fell into quarell. The SSB officer killed the two youths and fled away. Two days later, the murderer was held and he confessed his guilt. But he was released by police on that very day and was transferred elsewhere.

10. Pradip Medhi, 19.8.96.

11. Pradip Bora - 26.9.96  
Pradip Bora, aged 28, son of Thaneswar Bora of village Belguri under Howraghat Police Station in Karbi Anglong district was awakened from sleep of about 12.15 A.M. on September 26, 1996 by a group of Indian Armymen in his residence at Howraghat. He was then compelled to run and subsequently gunned down. He was then unarmed. The armymen also took two other youths of the area to the army camp and subjected them to inhuman mental and physical torture.

12. Raktim Hazarika - 18.5.94  
Raktim Hazarika, aged 23 years, son of Md. Akbar Ali of Sapmarigaon (Moamari) under Uluani Police Station in Nagaon district was in ULFA member who was sleeping with four other colleagues in the house of Manik Gayan, a resident of Panikhowachuk of village Bakultal at night on May 18, 1994. The house was gheraoed by a large armed group consisting of SULFA members and armymen and picked-up Raktim Hazarika, Dignata Bora and Tarun Medhi all ULFA members. They were taken to the bridge in village Bakhultal and were shot down brutally. Diganta Bora aged 28 years was son of Bijoy Bora of village Panigaon Pahukata near Puranigudam under Chamaguri Police Station in Nagaon District. The victim Tarun Medhi, aged 32 years, was son of Upendra Nath Bhuyan of villa Borappni (Khatowal) under Chamaguri Police Station in the same district.

13. Girikanta Bania - 30.5.94  
Girikanta Bania, aged 32 years son of Jonaram Bania of village Ghahimahariati (Ghahibhatikuria) under Nagaon Sadar Police Station in Nagaon district was sleeping in a house in village Deurigaon (Hatigarh) at night on 30.5.94. At about 9.30 p.m. a large armed group consisting of SULFA memebrs, police, para-military forces and Indian Army arrived at the village. The group picked up Nilmani Kakati, a youth of the village and called Girikanta out of his house, tortured him and then shot him down.

14. James Ekka, Sukham Kuzur, Bijoy Khalkho - 21.10.96.  
Sima Minz and Nandia Minz, two maidens of Tea-garden Community who had been enjoying the Durga PUja festival inside the Durmra tea garden area under P.S. Borbari in Nalbari district, came out to urinate. Three CRPF

personnels in civil dress followed the two maidens and attempted to rape them. Sensing danger, the two maidens shouted for help. The crowd at once gheraoed the three CRPF personnels and freed the maidens. Later on, the police personnels went to the camp and returned to the place with a group of 20/30 other CRPF personnels equipped with sophisticated arms and began to fire on the people indiscriminately. The crowd scattered and ran away from the spot. The CRPF personnels encircled the field till the next morning. The deadbodies were of three tea garden labourers; James Ekka, aged 17 years son of Bilachchi Ekka, Sukham Kuzur, aged 40 years and Binoy Khalkho, aged 27 years.

15. Choukat Ali - 29.9.95.

Choukat Ali, aged 65 a fisherman by profession, of village Adhiarpara under Hajo P.S. in Kamrup district was picked up from the road by the police and was taken to his house on boat. The police team held Taizuddin Ahmed and Abdul Hamid of the family and tortured the three brutally almost to death. While Choukat wanted to have water to drink, the policemen pushed a bamboo stick into his mouth and also beat his old mother and his wife with sticks and gun-bolt (barbarously). Then the forcibly took away Choukat and Taizuddin rejecting the earnest request of the family members. Next day, the deadboyd of Chokat Ali was found from the roadside between Ghopa and Sani Road of the P.W.D. Road from Guwahati to Barpeta. Choukat's deadbody carried innumerable bullet wounds. But no sign of blood could be seen on the place except a dead fox with bullet wounds. Taizuddin was later on released. The other injury-victims of the village were - Sultan Mamud (Teacher), Ashraf Ali, Hazarat Ali (Student) and Mrs. Abzan Bibi (Widow).

16. Paresh Barman - 15.4.92.

Indian Army personnels entered the village Balin Zhar under Belsor Police Station in Nalbari district at night, and raided the house of Sarbeswar Barman. Then they took Sarbeswar and his brother Paresh Barman whom they tortured with bamboo-sticks. The armyemen bound Paresh to the vehicle with a rope and dragged him on the gravelled-road away to the Kaithalkuchi Army Camp at a distance of about four kms. Paresh's skins were torn apart and the blood gushed out of the wounds. The armyemen at the camp pushed handful of sands into his mouth and was ultimately killed infront of his elder brother Sarbeswar Barman.

17. Golok Barman - 4.11.95.

A meeting was held in the evening in Chain Anyadham Temple, village Kakaya under Belsor Police Station in the Nalbari District on November 4, 1995 which discussed the problem of village development. After the meeting the villagers was having light food in the house of Uday Nath, a physiucally handicapped oldman near the temple. Suddently the District

Superintendent of Police, Binoy Kumar Mishra arrived at the premises of the temple with a big group of policemen and Punjab Commando well-equipped with sophisticated arms at 9.30 p.m. They began to fire indiscriminately without any warning. The brutal firing took the life of Golok Barman aged 62, a progressive farmer. Physically handicapped Uday Nath, aged 55 years and his wife were seriously injured.

18. Robin Bora - 14.3.96.

Indian Army personnels arrested Robin Bora aged 25, son of Thaneswar Bora of village Puzarigaon under Lahdoigarh Police Station in Jorhat District on March 14, 1996 from village Shudamuagaon and took him to Bahana Army Camp. There they brutally tortured him questioning about ULFA. Army personnels gave electric shock on his sex organ and also beat him inhumanly with gunbolt. he succumbed to his injury the next day in the army camp. Later on, the army personnels dramatised his death claiming that he died of injury when he tried to escape and the deadbody was given to the family. Hemakanta Bora who was arrested along with dead Robin Bora and taken to the army camp together denied the army's claim.

19. Simanta Gogoi - 27.8.96.

A big group of Army personnels gheraoed the house of Juram Gogoi, resident of village Napam under Mariani Police Station in Jorhat district at the dawn of August 27, 1996. They awakened the family members and dragged them all outside the house with force. They also broke and damaged the household articles inside. They beat the 13 years old daughter and attempted to drag her to the backside of the house with evil motive but she could come out with the help of a policemen. The army personnels made the brothers Prasanta Gogoi and Simanta Gogoi naked and tortured them both brutally. Then they dragged Simanta out to the road and gunned him down mercilessly. After some time the deadbody was discovered there drenched in blood.

20. Bagai Gogoi/his mother - 25.2.94.

Army and police personnel arrived at the house of Bagai Gogoi of village Balmatangani under Tiyak Police Station in Jorhat District at about 7 a.m. on February 25, 1994. They held Bagai Gogoi and his elder brother, both married, and tortured physically when questioning about ULFA. Their wives tried to resist the army and police' cruelties but in vain. At the time of returning the army tortured them again. An armyman even looted ornament from Bagai Gogoi's wife's ear. They also threw the little baby from her lap and when Bagai's mother attempted to hold the body, a police personnel, kicked her with gun-bolt. The mother was seriously injured and ultimately died after some days. Simultaneously army personnels arrested the two brothers, on whom the family depended, and were sent to jail under black

TADA law.

21. Bhaben Barua - 4.2.95.

At 8 a.m. on February 4, 1995, army personnels associated with SULFA members arrived at the hose of Nakul Bardoloi of village Naali Dhekiajuli near Baruabamungaon in Jorhat district. They searched for ULFA members and arrested his son Mintu Bardoloi, aged 17 and directed him to open their granery. He failed to open it, as it was locked. Then they indiscriminately fired the same. Then owner of the house was compelled to open it, and when did no. Their a deadbody of a youth Bhaben Barua alias Abinash Barua was found with innumerable wounds in a pool of blood. After identification the SULFA members began to dance displaying pleasure. Mintu was latter on arrested by a police and kept in jail for months. The army and the police is still harrassing the family.

**DESCRIPTION:** Lahit Ch. Rajbanshi was appointed as the body guard of Biraj Mohan Basumotary, a political leader. On 28.8.91 at about 9 p.m. an extremist group entered Basumotary's house and fired. He was spot dead.

22. Name - T.S. Raju  
Date of occurrence - 8.9.91

**DESCRIPTION:** On 8 Sept'91 at T.S. Raju was kidnapped by SULFA militants, later he died in their custody.

23. Bipul Mahanta, 32 years.  
Address - Nagaon.  
Date of occurrence - 8.9.91

**DESCRIPTION:** On 8th Sept'91 at 9 a.m. two unidentified gunmen killed Bipul Mahanta at his residence. He was a youth leader of a social organisation.

24. Name - Bipul Moran.  
Address - Dumduma, Darjijan Gaon, Tinsukia Dist.  
Date of occurrence - 15.9.91  
Place of occurrence - Dumduma, Tinsukia.

**DESCRIPTION:** Bipul Moran died at Dumduma army camp on 15.9.91. He was arrested earlier.

25. Name - Nitu Rajbongshi, 25 years.  
Address - Dhekiajuli, Sonitpur.

**DESCRIPTION:** A young dynamic businessman on 17th Sept'91 at abot 3.30 p.m. in Dhekiajuli Town Nitu Rajbongshi came in a motor cycle and parked it near Annapurna Hotel, and bought a pen. He walked towards the Hotel to get some sweets for

Puja which was solemnised in his own house. Within minutes he saw a group of CRPF jawans dashing towards him, with their arms. Nitu seeing the jawans dashing towards him, got scared, and out of panic started running. The CRPF jawans chased him for half a kilometer, then suddenly one jawan (Dayananda Singh) fired upon him. But the shot hit Rabi Aich, who was a handicapped in his leg. Nitu rushed inside a half constructed house of Shri Manuranjan Dutta to save himself. The CRPF jawans entered the house and searched for him. One jawan (Dayananda Singh) located him inside that half constructed bath-room. Though Nitu Rajbongshi wanted to surrender, he was shot from point blank range. The bullet pierced through his body.

26. Name - Purna Das, 55 years.  
Vill. - Borvita, Goalpara dist.  
Date of occurrence - 24.9.91  
Place of occurrence - Bor.ita, Goalpara.

**DESCRIPTION:** 24th September at about 11.30 p.m. Assam Rifles personnel on instruction from the Indian Army raided the house of Purna Ch. Das. The raid continued upto 3.15 a.m. The Assam Rifle personnel tortured the other family members of Purna Das, for informations. Purna Das, owing to inhuman army torture, was raising a hue and cry. The neighbours though heard his shoutings did not dared to come forward on the entire house was surrounded by the army. Suddenly, at around 3.15 a.m. the shoutings of Purna Das stopped. The nervous, Army personnel immediately got Das attended by a Doctor, who declared him dead. Purna Das body was then taken away by the personnel to Goalpara. The Army personnel did not disclose Das death to the villagers.

27. Name - Raj Kamal Choudhury.  
Address - Doomdoma Chowk, Hajo.  
Date of occurrence - 28.9.91  
Place of occurrence - Hajo.

**DESCRIPTION:** 28th Sept'91, near Hajo, Army personnel wearing lungi took away Raj Kamal Choudhury in a truck. On the 1st Oct'91, his dead body was handed over to Hajo Police Station. He died out of excessive inhuman torture by the Army jawans. After his body was handed over to the family members, one could see black spots all over his body, including the face. This testified the electric shock that was given. His bone joints were also broken.

28. Name - Rishni Dihingia, 25 years.  
Date of occurrence - 28.9.91  
Place of occurrence - 0 Lakhimpur.

**DESCRIPTION:** On 28th Sept'91 a group of Army killed Rishni Dihingia at Lakhimpur District.



29. Name - Biren Dolay.  
Address - Kasuagaon, Dholpur, Lakhimpur Dist.  
Date of occurrence - 29.9.91  
Place of occurrence - Lakhimpur Dist.

**DISTRIPTION:** At about 5.30 p.m. on 28th Sept'91 Biren Dolay was arrested by a group of Army. He was killed on 30th Sept'91.

30. Name - Dibakar Handique, 35 years.  
Address - Boshapukhuri, Narayanpur, Lahimpur Dist.  
Date of Occurrence - 29.9.91  
Place of occurrence - Lakhimpur.

**DESCRIPTION:** A group of Army arrested Dibaker Handique at evening time on 28th Sept'91 from Bashapukhuri and tortured him. On 29th Sept'91 dibakar Handique died at the Army Camp and the dead body was released on 30.9.91.

31. Name Khireswar Bora,  
Father's Name - Boloram Bora,  
Address - Narayanpur, North Lakhimpur Dist.  
Degree 1st year student of Sankar Dev College.  
Date of occurrence - 4.10.91  
Place of occurrence - Narayanapur, North Lakhimpur.

**DESCRIPTION:** Khireswar Bora, was picked up by the army from his home on October 31, and then was released. On the next day, he was beaten up and tortured by the Army personnel inside his own house. The army personnel then took him to Rangati Missamari Army camps about three kms. from his village and again tortured him after tying him to an nut tree. The neighbours, have stated that Khireswar died there itself, out of severe Army torture. The army personnel thereafter took away, the corpse which was handed over to the North Lakhimpur Police Station in a bullet-ridden state. The bullet-ridden body was handed over to the family members on October 4th 1991 at about 2.40 a.m.

32. Name - Nagen Kalita - 22 years.  
Address - Kalu Gaon, Sibsagar.  
Date of occurrence - 3.10.91  
Place of occurrence - Kalugaon, Sibsagar.

**DESCRIPTION:** Indian Army raided Kalugaon, in the early house of October 3, 1991. Army jawans threatened and ordered all the villagers to assemble inside the Namghar. At about 7.30 a.m. Nagen Kalita, who also was an employee in the Army's Police Department in Calcutta was crossing the Namghar. The Army jawans stopped him and started questioning him. There

upon Kalita showed his identity card. Though some Army jawans after seeing his identity card asked him to leave, one of them suddenly snatched away his identity card. Kalita, requested them to return his identity card, but the army jawans instead, torn it into two pieces. Seeing, his identity card being torn, Kalita protested but the Army jawans started arguing with him. Suddently, one of the jawans from point blank range, shot Kalita in his back. Nagen Kalita fell down dead.

33. Name - Bubul Baruah, 20 years,  
Address - Bandardowa, Puli Naharani, Lakhimpur.  
Date of occurence - 20.10.91  
Place of occurence - Puli Naharani, Lahimpur.

**DESCRIPTION:** On 12th Oct'91 at 2.30 p.m. a group of army arrested Mr. Bubul Baruah at home and tortured him. Consequently Bubu Baruah was dead on 20 Oct'91.

34. Name - Sajani Rabha.  
Address - Barjuli Gaon, Goalpara.  
Date of occurence - 7.11.91.  
Place of occurence - Barjuligaon, Goalpara.

**DESCRIPTION:** On 7th Nov'91 at Barjuli Gaon of Goalpara district, Army suspected Sajani Rabha as ULFA activist and shot him spot dead.

35. Name - Sarat Kakati.  
Address - Pathari, Nagaon.  
Date of Occurence - 10.11.91  
Place of occurence - Pathari, Nagaon.

**DESCRIPTION:** On 10th Nov'91 Sarat Kakati went to market on his cycle. On the way a group of civil dressed army personnel shot him dead.

36. Name - Deepak Murmu,  
Address - Dibrugarh.  
Date of occurence - 20.11.91  
Place of occurence - dibrugarh.

**DESCRIPTION:** On 20th Nov'91 Assam Police shot dead Deepak Murmu.

37. Name - Natro Cheita.  
Address - Sibsagar, Rojabari Gaon.  
Date of occurence - 24.11.91  
Place of occurence - Sibsagar..

**DESCRIPTION:** On 24th Nov'91 Natro Chetia was going by his Motor Cycle through Rajabari Village broad day light. A

group of army shot him spot dead in the broad day light.

38. Name - Ratul Tanti, 11 years.  
Address - Bihubar P.O. Chontak, Sibsagar.  
Date of occurrence - 11.12.91  
Place of occurrence - Bihubar, Sibsagar.

**DESCRIPTION:** Two army jawans shot innocent 11 years's old Ratul Tanti at his home about 12 noon.

39. Name - HIRAKJYOTI Mahanta.  
Address - Geetangagar, Guwahati  
Date of occurrence - 31.12.91  
Place of occurrence - Geetanagar, Guwahati.

**DESCRIPTION:** On 31st Dec'91 at about 9 p.m. (night) group of army and SULFA member's arrested HIRAKJYOTI Mahanta, Deputy Commander in Chief of ULFA from the house of Nripen Baruah at Geetanagar. The army and SULFA activist were shoted him on the way of Guwahati and Mahanta dead on the spot.

40. Name - Megha Phukan, 28 years.  
Address - 2 No. charaidolani, Lakhimpur  
Date of occurrence - 29.10.91  
Place of occurrence - 2 No. charaidolani, Lakhimpur.

**DESCRIPTION:** On 29th Oct'91 in the early morning, army raid the village 2 No. charaidolani under Lakhimpur Dist. and killed Megha Phukan.

41. Name - Gobin Hazarika.  
Address - 2 No. charaidolani, Lakhimpur.  
Date of occurrence - 29.10.91  
Place of occurrence - 2 No. Charaidolani, Lakhimpur

**DESCRIPTION:** On 29th Oct'91 in the early morning, army raid the village 2 No. Charaidolani under Lakhimpur dist. and killed Gobin Hazarika.

42. Name - Tarun Deka,  
Address - Rangia.  
Date of occurrence - 6.10.91  
Place of occurrence - Rangia.

**DESCRIPTION:** On 6th Oct'91 army arrsted Tarun Deka and killed on 9th Oct'91 at the army camp.

43. Name - Thaneswar Hazarika,  
Address - Golaghat.  
Date of occurrence - 9.10.91  
Place of occurrence - Golaghat.

**DESCRIPTION:** Thaneswar Hazarika died at the army camp, Golaghat on 9.10.91.

44. Name - Hungston Diamary, 20 years,  
Address - Odalguri  
Date of occurrence - 10.10.91  
Place of occurrence - Odalguri

**DESCRIPTION:** A group of army shot Hangston Daimary and he was spot dead at Odalguri under Darrang Dist., on 10th Oct '91 at about 3.30 p.m.

45. Name - Jogyeswar Timung, 30 years,  
Address - Kalapani T.E. Biswanath Chariali  
Police Station - Bihali

**DESCRIPTION:** A group of police under Bihali P.S. killed Jogyeswar Timung at Kalapani Tea Estate on 26.1.92 at 3 p.m. About 200 (two hundred) landless families lived in a land of area more than 600 (six hundred) bigha near by Kalapani T.E. under Mayar Tea Co. On 26.1.92 a group of Police went to evict the peasants from the land. The inhabitants protested and the police, has been shot Jogeswar Tumung dead in the spot and many were injured in the firing.

46. Name - Ram Timung.  
Address - Kalapani T.E. Biswanath Chariali.  
Police Station - Bihali.

**DESCRIPTION:** A group of police under Bihali P.S. killed Ram Timung at Kalapani Tea Estate on 26.1.92 at 3 p.m. About 200 (two hundred) landless families lived in a land of area more than 600 (six hundred) bigha near by Kalapani T.E. under Mayar Tea Co. On 26.1.92 a group of Police went to evict the peasants from the land. The inhabitants protested and the police, has been shot Ram Timung dead in the spot and many were injured in the firing.

47. Name - Rogha Morang.  
Address - Kalapani T.E. Biswanath Chariali.  
Police Station - Bihali.

**DESCRIPTION:** A group of police under Bihali P.S. killed Roga Morang Kalapani Tea Estate on 26.1.92 at 3 p.m.
